

## Terms and Conditions

### 1. General provisions

These Terms and Conditions apply to [www.adem.cz](http://www.adem.cz). The Terms and Conditions further define and specify the rights and obligations of the seller, such as the Academy of Digital Economics, Ltd., Blažkova 186 Praha 10 - Hájek 104 00, Company ID: 05610761 (hereinafter referred to as "The Supplier"), registered at the Municipal Court in Prague under the file: C 267296 Relations between The Seller and The Buyer - a consumer not governed by the business conditions are governed by the Civil Code (No. 40/1964 Coll.) And the Act on Consumer Protection (No. 634/1992 Coll.). The relations between the seller and the buyer - a businessman not regulated by the business conditions are governed by the Commercial Code (No. 513/1991 Coll.).

### 2. Order

The buyer orders the selected services by filling in the electronic order form. The Buyer is required to review and, if necessary, repair the order before sending it. The order sent is binding and the buyer and the seller create mutual rights and obligations, i.e. the seller undertakes to provide The Buyer with the ordered services and the buyer undertakes to pay the full purchase price of the services.

The Buyer confirms by sending the order that he has become familiar with the Terms and Conditions of purchase on the [www.adem.cz](http://www.adem.cz) supplier's website and agrees with them. These business Terms and Conditions published on the supplier's website are an integral part of the purchase contract that arises from filling and sending the order.

You may cancel the order from the buyer in accordance with point 6 of these Terms and Conditions.

### 3. Service price

The Supplier is not a VAT payer.

Contractual fine. If The Buyer has not paid The Seller properly and in the agreed time, he is obliged to pay The Seller a contractual fine of 0.1% of the purchase price of the goods for each day of delay, up to a maximum of the purchase price of the service.

### 4. Payment method

## **5. Security**

## **9. Warranties and limitations of liability**

By signing the agreement, the Buyer agrees to processing and collecting of his personal data in the The Seller's database after the successful completion of the contract, until such time as he or she expresses his or her opposition to such processing. The Buyer has the right to access his / her personal data, the right to have it corrected, including other legal rights to such data. Personal data can be removed from the database on the written request of the customer. The customer's personal data is fully secured against misuse.
